

Subject: NOC for starting of Jannayak Chaudhary Devi Lal Dental College at Sirsa

Reference subject noted above.

The desired certificate is as under:-

1. No. of Institutions already existing in the State 6 (Six)
2. No. of seats available or No. of dental surgeons being produced annually. 560/215
3. No. of dental surgeons registered with the State Dental Council. 1830
4. No. of dental surgeons in Government service. 185
5. No. of Government posts vacant and those in rural/difficult areas. 15
6. No. of dental surgeons registered with Employment Exchange. Not-available.
7. Dental Surgeon population ratio in the State. 1 : 70000 (approx.)
8. How the establishment of the college would resolve the problem of deficiencies of qualified dental personnel in the State and improve the availability of such dental manpower in the State. The establishment of this College would produce 100 dental Doctors annually which will reduce the deficiency to some extent.
9. The restrictions imposed by the State Government, if any, on students who are not domiciled in the State from obtaining admissions in the state, be specified. 85% Haryana domiciles students are to be admitted and State policy of reservation would be applicable.
10. Full justification for opening of the proposed College. As specified at Sr. No. 8 above.

12. Copy of the Inspection Report in connection with the Inspection carried by the State Government for grant permission for setting up a new dental college is to be attached. -----

The Jan Nayak Ch. Devi Lal Vidyapeeth, Sirsa has applied for establishment of a dental college at Sirsa. On careful consideration of the proposal, the Government of Haryana has decided to issue an essentiality Certificate to the applicant for the establishment of a dental college with 100 (no.) seats.

It is certified that :-

- (a) The permission to use the facilities of Government Hospital, Sirsa for the training of the students of Jan Nayak Ch. Devi Lal Dental College, Sirsa has been granted vide Govt. Memo No. 21/3/2002-211B-IV, dated 25.3.2004 and dated 30.08.2004.

- (c) It is desirable to establish a dental college in the public interest.
- (d) Establishment of a dental college at Sirsa by the Jan Nayak Ch. Devi Lal Vidyapeeth, Sirsa is feasible.
- (e) Minimum 30 OPD Dental patients per day are available to begin with.

It is further certified that in case the Jan Nayak Ch. Devi Lal Vidyapeeth, Sirsa fails to create infrastructure for the dental college as per Dental Council of India norms and fresh admissions are stopped by the Dental Council of India, the State Government shall take over the responsibility of the students already admitted in the College with the permission of the Central Government.
